Chapter - 1: Instructions to Bidders

Sardar Swaran Singh National Institute of Bio Energy (SSS NIBE), Kapurthala invites online Bids for supply, erection, installation, commissioning, testing, demonstration and training of Biomass Pellet Machine, as per specifications given below and in annexure attached to the tender file. All offers should be made in English and should be written in both figures and words.

The bidders are requested to read the tender document carefully and ensure compliance with all specifications/instructions herein. Non-compliance with specifications/instructions in this document may disqualify the bidders from the tender exercise. The Director General, SSS NIBE, Kapurthala reserves the right to select the item or to reject any quotation wholly or partly without assigning any reason. Incomplete tenders, amendments and additions to tender after opening or late tenders are liable to be ignored and rejected.

Preparation and submission of bids:

- 1) Bidder should consider any corrigendum published on the tender document before submitting their bids.
- 2) Please go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bid. Please take note of the quantity of covers in which the bid documents must be submitted, as well as the titles and contents of each document that must be submitted. Any deviations from these may lead to rejection of the bid.
- 3) The tenders will be received through speed post or by hand at Director General, SSS NIBE, Kapurthala Jalandhar Rd, Near Pushpa Gujral Science City, Rasulpur, Punjab 144602 or can be received by email at sss.nibe@nibe.res.in & tapas@nibe.res.in (in case of email submission simultaneously a hard copy should be submitted) latest by the due date.
- 4) In the Technical Bids, the bidders are required to provide all the documents. All quotation (both Technical and Financial) should be submitted in the different sealed envelopes.
- 5) In case of Financial bids, a standard BOQ format has been provided (Annexure II). Bidders are required to download the BOQ and fill their financial offer on the same BOQ format. If the BOQ format file is found to be modified by the bidder, the bid will be rejected.
- 6) The bidder must sign each page and provide the required bid documents one by one as indicated in the tender document.
- 7) The provided tender documents are readable only after the tender opening by the authorized bid openers.
- 8) Bidder should submit the bid in advance for bid submission so that bid reach in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other issues.
- 9) The Vendors who have earlier supplied the equipment to any of the IITs, IISc, IISERs and other Scientific or Education Institute of National Repute may provide the details of such institutions and the cost with name of equipment may also be supplied with the bids.
- 10) The technical and financial bids should be submitted in original in sealed envelope. The financial bid should include the cost of main equipment/item and its accessories. If there is any separate cost involved etc. that should be quoted separately.

- 11) Each bid should be marked with the following reference on the bid envelope mentioning Technical bid, Financial bid, submitted through speed post or by hand: "Tender number: 348-11/6/2022-R and D; Item Name: BIOMASS PELLET MACHINE; Dated: 18/12/2023".
- 12) The printed literature and catalogue/brochure giving full technical details should be included with the technical bid to verify the specifications quoted in the tender. The bidders should submit copies of suitable documents in support of their reputation, credentials and past performance.
- 13) The rates should be quoted in figures (typed or printed) and in word and cutting should be avoided. The final amount should be in figures as well as in words. If there are cuttings, they should be duly initialled, failing which the bids are liable to be rejected.
- 14) Assistant to Bidders: Any queries relating to the tender document and the terms & conditions contained therein should be addressed to tender Inviting Authority for a tender or relevant contact person indicated in the tender.
- 15) If the supplier/firm is original equipment manufacturer (OEM)/authorized dealer/sole distributor of any item, the certificate to this effect should submitted with the bid.
- 16) Clarifications: In case the bidders requires any clarification regarding the tender documents, they are requested to contact our office (e-mail: sss.nibe@nibe.res.in & tapas@nibe.res.in on or before 01/01/2024.
- 17) Tender expenses and documents: All costs incurred by the bidder in the preparation of the tender shall be at the entire expense of the bidder.

Chapter - 2: Conditions of Contract

- 1) Bidders should be the manufacturer / authorized dealer. Letter of Authorization from original equipment manufacturer (OEM) on the same and specific to the tender should be enclosed.
- 2) Any bids received after 02/01/2024 05:00 PM shall not be considered
- 3) The Technical Bids will be opened on 05/01/2024. The date for opening of Financial Bids of the technically qualified bidders will be 05/01/2024.
- 4) While sending rates, the firm shall give an undertaking to the effect that "The terms/conditions mentioned in the enquiry letter/Tender Notice against which the rates are being given are acceptable to the firm.". In case the firms do not give this undertaking, their rates will not be considered. Undertaking format is given in the Annexure III.
- 5) For any correspondence regarding tender, is to be done on below address: "Director General Sardar Swaran Singh national Institute of Bio energy, Kapurthala Jalandhar Rd, Near Pushpa Gujral Science City, Rasulpur, Punjab 144602".
- 6) In the event of any dispute or difference(s) between the vendee Institute (SSS NIBE) and the vendor(s) arising out of non-supply of material or supplies not found according to specifications or any other cause whatsoever relating to the supply or purchase order before or after the supply has been executed, shall be referred to "The Director General, SSS NIBE", Kapurthala who may decide the matter himself or may appoint arbitrator(s) under the arbitration and conciliation Act,1996. The decision of the arbitrator shall be final and binding on both the parties. The place of arbitration and the language to be used in arbitral proceedings shall be decided by the arbitrator.

7) All disputes shall be subject to Kapurthala Jurisdiction only.

8) All tenders in which any of the prescribed conditions is not fulfilled or any condition is put forth by the tenderer shall be summarily rejected.

9) All items listed below may not be necessarily ordered.

10) The bidders or their authorized representatives may also be present during the opening of the Technical Bid, if they desire so, at their own expenses. Note: Financial bids of only those bidders will be opened whose technical bids are found suitable by the committee appointed for the purpose. In exceptional situation, an authorized committee may negotiate price with the qualified bidder quoting the lowest price before awarding the contract.

11) An undertaking from the OEM is required stating that they would facilitate the bidder on a regular basis with technology/product troubleshooting and extend support for the

warranty as well.

12) Non-compliance of tender terms, non-submission of required documents, lack of clarity of the specifications, contradiction between bidder specification and supporting documents etc. may lead to rejection of the bid.

13) Furnishing of wrong/ambiguous information in the compliance statement may lead to rejection of bid and further black listing of the bidder, if prima-facie it appears that the information in the compliance statement was given with a malafide/fraudulent intent.

- 14) Delivery: The Equipment should be delivered and installed within the period as specified in the purchase order and be ready for use within 4 weeks of the issue of purchase order unless otherwise prescribed. If the bidder fails to deliver and place any or all the Equipment's or perform the service by the specified date, penalty at the rate of 1% per week of the total order value subject to the maximum of 10% of total order value will be deducted.
- 15) Installation, Training & Demonstration: Bidders need to provide adequate training to the nominated persons of SSS NIBE at their cost. SSS NIBE will not bear any training expenditure. The supplier is required to do the installation and demonstration of the equipment within two weeks of arrival of materials at the SSS NIBE site of installation, otherwise the penalty clause will be the same as per the supply of material.
- 16) Warranty Declaration: Bidders must give the comprehensive on-site warranty as required from the date of successful installation of Equipment against any manufacturing defects and also give the warranty declaration that "everything to be supplied by us here, under shall be free from all defects and faults in material, workmanship and shall be of the highest quality and material of the type ordered, shall be in full conformity with the specification and shall be complete enough to carry out the work, as specified in the tender document." SSS NIBE should not be liable for repair/replace of any part of machine under warranty if it is from third party also. It will be sole responsibility of the bidder.

17) Any deviation in the material, and the specifications from the accepted terms may liable to be rejected and the bidders need to supply all the goods in the specified form to the satisfaction/specifications specified in the order / contract and demonstrate at their own cost.

18) Tender Evaluation Criteria: The technical bids will be opened and evaluated by a duly constituted committee. After evaluation of the technical bid, the financial bid for only those offers which have qualified in the evaluation of technical bid will be opened.

- 19) Manual and documentation: All the manuals necessary for operating and servicing the equipment (including details of electronic circuits) will have to be provided along with the instrument.
- 20) The SSS NIBE reserves the right to cancel the tender at any stage (point of time) without assigning any reason.
- 21) Bidders should go through the tender terms, conditions and specifications carefully and fill in the attached compliance statement accurately and unambiguously. They should ensure that all the required documents are furnished along with the bid.
